The Benezette Twp board of supervisors held their regular monthly meeting on 8/6/24 at the Twp Bdg, 105 School House Rd. Benezette, PA. Present were supervisors Amanda Maholtz and Tom Wilson. Township Insurance Update: Wilson stated that he has been working for the past couple months on getting insurance quotes for the township. Wilson said that the township was currently paying approx \$22,226 between the main policy from St. Marys Insurance and the school house policy through Millville Mutual. Wilson stated that he received a quote from Matson Insurance for comparable coverage, which was even better in some areas than the current coverage at a price of \$16,663 per year. Wilson said by switching insurance companies it should save the township approx \$5500/yr.

The motion was made to switch to Matson Insurance out of Brookville, PA.

Secretary Update: Wilson said that the supervisors hired a permanent secretary/treasurer, which the Interim Secretary Morgan Kurtz will help train for the position. Wilson said that the current assistant secretary Pam Mong would be a backup secretary and that Interim Secretary Morgan Kurtz will help out as needed with some projects in the winter.

New Hire Update: Wilson said that the township hired an "as needed" experienced equipment operator road worker to utilize when needed.
